Helping to expand the collaboration between companies and educational centres so that training meets the labour needs of the companies in our cluster and facilitates the integration of young people into the labour market.

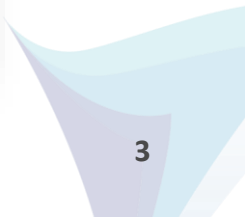

Objectives of the PORT IMMERSION Programme

- A programme with a great projection to provide the logistics-port sector with trained human resources to cover the needs of companies, with internships in companies.
- This is a unique programme that enriches the existing advanced vocational training, adapting it to the port logistics sector, very focused on practice, where you learn the physical and documentary flow that accompanies the processes of import and export of goods from the moment they leave a warehouse until they reach the end customer, passing through a port.



- It strengthens the concepts and contents of the training centres, with business reality focused on the International Trade operations of the companies that operate in the Port of Valencia. The Port of Valencia is known as an instrument at the service of International Trade, and the main keys to its innovative management and leadership.
